#### SIGN PERMIT

- 1. A sign permit is required for the erection of all signs, temporary or permanent, to be erected in Township with the **exception** of the following types of signs:
  - a. Real estate sign advertising the sale or rental of the premises upon which they are located.
  - b. <u>Nameplate signs</u> designating the name, street name, and house number of an occupant or a residential property.
  - c. <u>Street and road signs</u> as required and erected by Local, State, and/or Federal governmental agencies.
- 1. Application shall be filed with Township Office by the Applicant.
- 2. Prior to the granting of a Sign Permit, the Township will process your application as follows
  - a. Application is reviewed by the Zoning Officer to determine if Application is complete. If Application is not complete, it will be returned to the Applicant. If Application is complete, it will be declared officially received by the Township.
  - b. Zoning Officer and Planning Commission reviews application and proposed location for sign to determine compliance with the Zoning Ordinance and all other applicable Township Ordinances.
  - c. As necessary, application is also forwarded to the following agencies for technical reviews:
    - 1) Township Engineer
    - 2) Pennsylvania Department of Transportation, Bureau of Highways
- 1. In the case of a temporary sign, the Sign Permit shall be issued by the Zoning Officer. In the case of a permanent sign, the Sign Permit shall be issued by the Zoning Officer after the Planning Commission's review.
- 2. If approved, one (1) copy of the Sign Permit is given to the Applicant and one (1) copy shall be filed in Township Office.
- 3. The denial of a Sign Permit shall include a written statement of reasons.
- 4. Permanent Sign Permit shall expire after completion of the work or within one (1) year after the permit is issued, whichever occurs first. Temporary Sign Permits to construct a sign vary in length of duration. Check with the Township Office for specifics applying to the type of temporary sign involved.
